Pedestrian Couple Injured by Drunk Driver

We recently represented a young married couple who were injured by a drunk driver in Midtown Atlanta. The couple had just finished dinner and were walking back to their car. As they were waiting to cross Ponce de Leon Avenue, a drunk driver sped through a red traffic signal and t-boned a Chevy Trailblazer. the sidewalk and into the young couple. The husband suffered injuries to his right shoulder and back and his wife sustained a traumatic

The DUI driver admitted to drinking four beers and one tequila shot before getting behind the legal limit. He later pled guilty to DUI and failure to obey a traffic signal device. His insurance tendered the policy limits.

Due to the severity of the wife's injuries, the Therefore, we pursued the policy limits of the couple's un-insured/under-insured coverage of their auto policy. A successful settlement for the policy limits on behalf of the wife was reached.

Litigation Pushes Safer Designs for Ski Boat Manufacturers

Three years ago, a young boy lost his life while enjoying a day on the lake with his family. Seven-year-old Ryan Batchelder, along with five other members of his family were out on Lake Rabun when their boat, a Malibu Bowrider manufactured by Malibu Boats, dipped under its own wake and took on water, tossing Ryan and another family member overboard. To correct the flooding issue, the driver put the boat in reverse. Still in the water, Ryan became entangled with the propeller and died from drowning and loss of blood. It's a tragic story. A story we believe should have never happened if the Malibu Bowrider had been properly designed and tested.

Sean Kane with Safety Research & Strategies Inc. has more details about this potential design flaw. The following is an excerpt from his recent investigative report:

'Malibu Boats bills itself as "the world's largest manufacturer of watersports towboats, owning over one-third of the worldwide market share."... But, the reality, as described in a deposition by Robert Alkema, one of Malibu's original founders and former CEO, is: despite its outsized footprint in the world of towboats, Malibu's design process was more relaxed. Alkema testified that the company created the step-over bow used in the Batchelder's Bowrider LX in 1996, by simply cutting a hole in the deck of another model, called the Response, in their shop, and added some seats to the bow area. Alkema testified that the impetus for the design was market share: "It was a belief on our part that we could sell – or would – there would be a bigger market for a boat that had more seating. And that's proven by other specific open bow models. So the walkover was a thought to be a more novel way to maintain the skiability and the two rearward facing passengers, and have the seating in the front.

Alkema testified that no engineering adjustments were made, despite the fact that the design would have added more weight to the bow of a boat that had originally been designed to have no weight in the bow. Nor did Malibu give any consideration to making a bow capacity weight limit for the Response LX. Alkema also testified that it would be up to the customer's reasonable judgement to decide how many occupants could safely fit in the bow of the boat, and that the company had no testing protocol nor did any testing to determine safe weight capacity.

The revelations contained in depositions filed in Rabun County Superior Court echo those of other manufacturers in the RV and bus industries who failed to systematically determine appropriate weight limits—employing an ad hoc design process conducted with little testing by staff without engineering credentials and driven more by market considerations than safety.

The laws of physics show, in example after example, that overloading a conveyance in critical locations under certain circumstances becomes a literal tipping point that routinely causes injuries and deaths. ... Encumbering a vehicle with more passengers and cargo than its weight rating can support strains tires to point of failure, and changes a vehicle's dynamics in pre-crash maneuvers, making it more prone to loss-of-control crashes and rollovers...

The Cooper Firm is currently representing the Batchelder family to investigate and identify this potential product defect. In addition to seeking justice for their son Ryan, they hope to save more families from experiencing this type of tragedy.

Ford Explorer Exhaust Problems Lead to Placement on Vehicle Safety Watch List

The Safety Institute released its quarterly vehicle safety watch list and 2015-2016 Ford Explorers have taken the number three and number six spots on the list. The 2015-2016 Ford Explorers have been the subject of a 2016 investigation by the NHTSA for carbon monoxide leaks in the SUV's cabin. Over 2,800 complaints have been filed. Among them, police departments reported their police interceptors caused at least five officers to lose consciousness.

Topping the list for the fourth quarter in a row, the 2014-2015 Jeep Grand Cherokees continue to be a concern as relating to a confusing gear shift operation. After a six month investigation, Fiat-Chrysler recalled these vehicles over a design flaw that did not alert the driver when the door was opened that the vehicle was not in PARK. This allowed the driver to exit the vehicle while it was still in gear leading to many injuries and over 100 reported accidents. Included in this recall are the 2012-2014 Dodge Chargers and Chrysler 300. The 2012 Chrysler 300 is number seven on this watch list for this same reason.



Each quarter, the Safety Institute releases a list of the top 15 vehicles to watch with regards to safety concerns. The list is compiled by researching public data in addition to consumer complaints filed with National Highway Traffic Safety Administration database.
